SEC. 2. EMERGENCY APPROPRIATION OF FUNDS TO PRO VIDE PAY AND ALLOWANCES FOR MEMBERS
 OF THE ARMED FORCES AND SUPPORTING
 CIVILIAN AND CONTRACTOR PERSONNEL
 DURING GOVERNMENTWIDE SHUTDOWN.

6 During a Governmentwide shutdown, the Secretary 7 of the Treasury shall make available to the Secretary of 8 Defense (and the Secretary of Homeland Security in the 9 case of the Coast Guard), out of any amounts in the gen-10 eral fund of the Treasury not otherwise appropriated, such 11 amounts as the Secretary of Defense (and the Secretary 12 of Homeland Security in the case of the Coast Guard) de-13 termines to be necessary to continue to provide pay and 14 allowances (without interruption) to the following:

(1) Members of the Army, Navy, Air Force,
Marine Corps, and Coast Guard, including reserve
components thereof, who perform active service during the funding gap.

19 (2) At the discretion of the Secretary of De20 fense, such civilian personnel of the Department of
21 Defense who are providing support to the members
22 of the Armed Forces described in paragraph (1) as
23 the Secretary considers appropriate.

24 (3) At the discretion of the Secretary of De25 fense, such personnel of contractors of the Depart26 ment of Defense who are providing direct support to

3 SEC. 3. GOVERNMENTWIDE SHUTDOWN DEFINED.

4 In this Act, the term "Governmentwide shutdown" 5 means any portion of a fiscal year during which none of 6 the appropriation bills for the fiscal year have become law 7 and an Act or joint resolution making continuing appro-8 priations for the fiscal year is not in effect.
