Ms. Barbara Hoffman serves as the Principal Director for the DCIO-IE). Her primary responsibilities are to develop the strategic plan to address the delivery of Enterprise Collaboration and Productivity Services (ECAPS) across the Department of Defense (DoD). She chairs the ECAPS Working Group and oversees the activities of the seven Integrated Product Teams working to realize ECAPS objectives.

She also provides technical expertise, policy guidance, and leadership to drive OSD processes and actions to realize an integrated DoD - wide implementation of the Joint Information Environment (JIE) and its two primary sub - components called the Joint Regional Security Stack (JRSS) and the Mission Partner Environment - Information System (MPE-IS). In addition, she also oversees the DOD Enterprise Architecture, Data Center consolidation, Cloud implementation and Enterprise Licensing efforts.

In April 2016, Ms. Barbara Hoffman was named DoD Deputy, Chief Information Officer for Business Process and Systems Review (DCIO - BPSR). In this role, she served as the DOD lead, for conducting the Business Process and IT Systems reviews as directed in 2014 by the Deputy Secretary of Defense. Additionally, she provided management and oversight for the execution of the Information Technology element of the PSA reviews. The overall goal of this effort was to identify opportunities that would increase mission effectiveness, ensure security, and lead to significant savings.

In July 2015, Ms. Barbara Hoffman was named Acting Deputy Director of the Provisional Joint Service Provider (JSP). In this role, she guided the establishment of this single service provider that consolidates and delivers common/shared ITservices within the Pentagon and National Capital Region. JSP includes all covered OSD 4th Estate Organizations and associated OSD organizations. From November 2014–July 2015, Ms. Hoffman led the Enterprise Performance Division of the DoD Office of the Deputy Chief Management Officer (DCMO). She was responsible for measuring performance against the Department's Agency Strategic Plan and establishing strategic goals and objectives. She also served as the project lead for the development and implementation of JSP. From 2009 –2014,Ms.Hoffman served as the Principal Deputy Chief Information Officer (CIO) for the Department of the Navy (DON). She managed and provided strategic guidance to the DON CIO's Cybersecurity and Infrastructure, IT Efficiencies and Analysis, and Information and Workforce Management functional teams. She led the development of policies, plans, architectures, standards, and process guidance to achieve and sustain interoperability, security, and IT business transformation. She also provided strategic guidance for Integrated Product Teams to identify and

implement cost saving efficiencies in the information management and IT/cyberspace environments. As DON Senior Security Assurance Officer, she was responsible for developing and maintaining an agency-wide information security program.

Previously, Ms. Hoffman served in several key positions within the DON CIO. As Director of Investment Management, she was the principal advisor for the Department's IT investments, including portfolio management, the IT budget, and IT inquiries from Congress. As Director of Operations, she was responsible for personnel, comptroller, management of contracts and security management. As Director of E-business, she was responsible for Smart Card and Common Access Card (CAC) policy.

Prior to the DON CIO, Ms. Hoffman served with OPNAV N4 as the Deputy to the Smart Card Program Manager, responsible for the roll out and issuance of CACs within the DON. She also served in the Naval Sea Systems Command and the Naval Surface Warfare Center Headquarters as part of the Federal Woman's Executive Leadership Program.

Ms. Hoffman began her Government service career in 1983 with the Naval Surface Warfare Center in Indian Head, MD . Ms. Hoffman received a bachelor's degree in technology management from the University of Maryland and a master's degree in management and technology from George Mason University .
