Additionally, I am especially worried about the abuse of this medium, and that these types of notifications are grouped with emergency alerts (which I assume they're not).

Given the surprise nature of the communication, it would at least be appropriate to explain to people (a) why this is necessary, (b) what these Alerts will be used for, and (c) how we arrived here.
